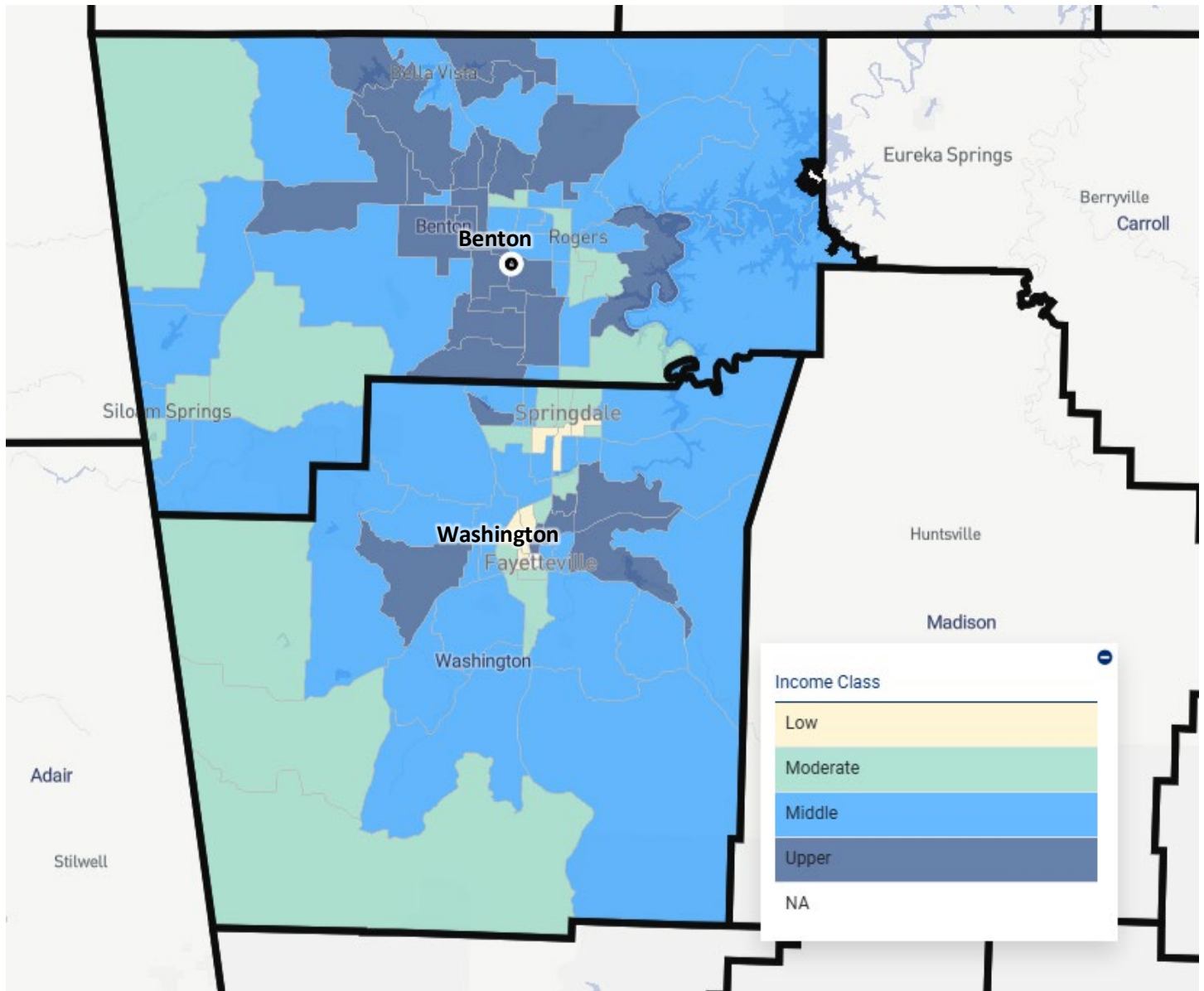


Northwest Arkansas Assessment Area
